It is also important to send a message to all politicians, in particular to the Labor Party, in the lead up to the upcoming Federal Election that is only a few weeks away, that the Rules need to be changed so that:

- The ABCC is abolished. The ABCC's sole purpose is
 to inhibit Unions and you from being able to bargain
 more effectively. It also aims to make it harder for
 Unions to take up the issues that are important to
 you and your families. We have withstood the ABCC
 but the millions of dollars of wasted tax payers
 money that is used to fund it would be much better
 spent on looking after your families, not trying to
 destroy your conditions.
- The Building Code 2016 is abolished. The Codes main purpose is to prevent the Union from bargaining for enterprise agreements that protect your security of employment and stronger workplace protections.
- Labour hire is regulated so that it isn't used to push down wages and relegate workers to insecure casual jobs indefinitely.
- Stamp out the illegal use of ABN's so that workers are not forced to accept crap conditions that deprive them of decent hourly rates, penalty rates, annual leave, sick leave and redundancy.
- Regulate the use of temporary visas that exploit workers, deprive local people of local jobs and push wages and condition down. The focus should be permanent, well paid jobs for local people.
