The Union can report and update members, that State Transit are now paying the Excess Travel Time for Sundays worked at another depot. This payment is being backdated 2 years.

Members who believe they are entitled to this payment and have not received anything by MID JULY 2015, should contact their local delegate.

This payment is on top of the Excess Travelling Time payment received for DOC's.

Meet Shadi Chamas, Kingsgrove Relief Delegate

"I love my job. I like interacting with the people and Sydney is my office.

The hardest thing is the traffic, the roads. My advice for dealing with chaotic traffic is to be patient - that's all you can do. Take it as it comes.

Acting out of Classification

21.1 An employee engaged temporarily in a higher grade shall be paid the rate to which they would be entitled if they were appointed to that grade.

21.2 The conditions applying to the classification in which an employee acts shall be their conditions whilst so acting.
