Underpayment, lack of security: **Newcastle bus** privatisation a complete disaster

Bus drivers are being underpaid, services are being cancelled due to poor rostering, and drivers have been left vulnerable to attacks as a result of the NSW Government's bungled privatisation of Newcastle buses.

Rail, Tram and Bus Union (RTBU) Tram and Bus Divisional President, Dave Woollams, told media that the privatisation of the region's buses has turned out to be an even bigger disaster than bus drivers originally predicted it would be.

"This is first-rate incompetence from the Transport Minister," Mr Woollams said.

"The list of things that have gone wrong since the NSW Government sold off Newcastle's buses is as long as your arm. We've seen drivers severely underpaid, new buses without basic security systems purchased, and rostering issues so bad that in some cases services have had to be cancelled. Inner West residents make view on bus privatisation clear in council elections

The results from the local council elections show that Inner-West residents are not happy with the NSW Liberal Party's privatisation of their bus routes. RTBU Bus Divisional Secretary, Chris Preston, told media that it's clear that a contributing factor to the move away from the Liberal Party is the Government's bus privatisation debacle.

"The Liberal Party is clearly on the nose in the inner-west and there's no doubt that's in part due to the State Government's attack on their local buses," Mr Preston said.

Newcastle rail line revelations proof of government shonky decision

Revelations in September in Fairfax show that the NSW Government made the decision to close the last section of the Newcastle rail line prior to any costing or assessment of the light rail replacement.

Fairfax reports that the cabinet-in-confidence report, prepared after the decision to close the line, refers to the decision as a "sunk cost" estimated at about \$200 million.

RTBU Tram and Bus Divisional Secretary, Chris Preston said this is proof the decision making around the line closure and light rail introduction wasn't made to benefit commuters and was a disgraceful use of public funds.

"We said all along that the cost were over the top. This proves that to be true," Mr Preston said. "The decision making around the whole process reeks of shonky decision making. Even after the rail line was torn up, the government could have introduced bendy buses that were configured like trams. This could have been done at a fraction of cost and the buses then could have been used elsewhere if needed.

Newcastle Agreement Update
