Union supports bus dedicated tunnel for the Northern Beaches

The RTBU Bus and Tram Division has called on the NSW Government to commit to a two-lane bus dedicated tunnel from Spit Junction following the release of the Northern Beaches bus rapid transit pre-feasibility study.

The bus rapid transit prefeasibility study released by the government covers six options but only a bus-dedicated tunnel will ensure ongoing reliable bus travel.

Dedicated bus lanes over the Spit Bridge have provided some relief from congestion but the tunnel would bypass congestion from Spit Junction along Military Rd and ensure a smooth run into the city.

It is good to see some work towards solving the congestion problems long-suffering commuters face on the Northern Beaches, but now we need to see action.

"The people of the Northern Beaches have been stuck in traffic jams for way too long. It is time to see investment in transport infrastructure for this community."

Vice President Brett Peters Know your Rights

22.	Acting	out	of
Classification			

22.1 An employee engaged temporarily in a higher grade shall be paid the rate to which they would be entitled if they were appointed to that grade.

22.2 The conditions applying to the classification in which an employee acts shall be their conditions whilst so acting.

22.3 An employee who acts in a higher-grade position for a continuous period of 124 working days shall be paid at the higher rate for any period of annual leave falling within the same twelve-month period.
