Rule 77 of the organisation's registered Rules requires that where two Offices cannot be held simultaneously by a person under the Rules, the person may not nominate for both Offices. Candidates must refer to the ARTBIU Rules and the attached listing to determine whether they have nominated for two Offices which cannot be held simultaneously. Any candidate whose nominations are affected by this provision can elect in writing to me which of the Offices he/she wishes to nominate for, by no later than 5pm on Monday, 13 October 2014. If no advice is received by me by that time I shall deem the person to have nominated for only the highest ranking Office in the order outlined in Rule 77.

Draw for positions on the Ballot Paper

Where a ballot will be required, I will conduct a draw to determine the order in which candidate names will appear on the ballot paper. The draw will take place in my Office at 12 noon on Wednesday, 15 October 2014. Candidates or their representatives are able to attend the draw.

As soon as possible after the draw I will write to all candidates involved in contested offices advising of the outcome of the draw and details for the ballot.
