

## **TRANSDEV IWLR ENTERPRISE BARGAINING UPDATE**

**Date: 11 March 2021**

The RTBU met with Transdev management representatives Yohan Touzard, Lindsay Ollson and Jessica Pellegrini on Wednesday 10 March 2021 to begin formal negotiations for the IWLR Enterprise Agreement 2021.

At this meeting numerous issues were discussed including Transdev's fiscal position in the global world. Transdev globally has been negatively affected by the pandemic but Transdev Australasia is fortunate to have contracts with the government that ensure a revenue stream.

Your union representatives tabled your claim i.e., that you want to receive the same pay and conditions as LRV operators at Randwick Depot and the simplest way to do this is to include IWLR operators in the 'Randwick' Agreement. If this was not accepted by the company, we asked for a 'mirror' Agreement containing the same pay and conditions as the Randwick LRV operators, inserted into a separate Pyrmont driver' agreement.

Transdev will consider these requests and provide a response at the next meeting.

The next meeting is scheduled for Wednesday 31 March 2021.

A note regarding legal process:

Members need to be aware that the union is the default bargaining representative for its members. If a union member provides the proper written authority requesting to be represented by an 'Employee Representative' (not the union), they can no longer be represented by the union and will not be included in union bulletins/information and their views/feedback will not be considered by the union throughout this negotiating process.
